FULBRIGHT U.S. SPECIALIST PROGRAM

PROGRAM GOAL:

The Fulbright Specialist Program promotes linkages between U.S. academics and professionals, and their counterparts at Egyptian institutions. The program is designed to provide Egyptian institutions the opportunity to host qualified U.S. faculty and professionals to engage in short-term collaborative 2- to 6-week projects in Egypt. Project activities focus on the developmental needs of host institutions.

- Participating in or leading seminars or workshops at Egyptian institutions
- Developing and/or assessing academic curricula or educational materials
- Conducting teacher-training programs at the tertiary levels

APPLICATION REQUIREMENTS AND PROCEDURES:

For Host Institutions:

- Egyptian institutions wishing to host a Fulbright Specialist should consult with the Fulbright Commission in Egypt. An institution may apply for:
 - A Named Request: the institution identifies the scholar whom it would like to host.
 - An Unnamed Request: the institution identifies the field of specialization in which it would like to host a Specialist and describes the activities to be pursued.

AY2022-2023 FULBRIGHT U.S. SCHOLAR PROGRAM

PROGRAM GOAL: Provides opportunities for American faculty members, artists, and independent scholars to lecture and/or conduct research at universities or research institutions in Egypt.

GRANT DURATION: Three to nine months.

GRANT TYPES:

- Teaching,
- Research, or
- Combined Teaching/Research Grants

ELIGIBILITY CRITERIA:

- U.S. citizenship: Applicants must hold U.S. citizenship at the time of application. Permanent residence is not sufficient.
- Residency abroad: Applicants who have resided abroad for five or more consecutive years in the six-year period preceding the application deadline are ineligible. A period of nine months or more during a calendar year constitutes a full year.
- Academic/professional requirements: Award descriptions specify where a Ph.D., other terminal degree, or comparable professional qualifications are required. Evidence of scholarly research and/or a teaching record in the proposed project's field of specialization is required.
- Language requirements: All teaching will be in English; additional language proficiency is not required for teaching grants. For research grants, Arabic or other applicable language proficiency sufficient to complete the research project is required; applicants must complete the language proficiency evaluation. For applicants without Arabic or other applicable language proficiency, feasibility of conducting research in English must be demonstrated in the proposal.
- Prior Fulbright Scholar Awards: Recipients of a Fulbright Scholar award are eligible to apply for another award two years after the date of completion of the previous award. Recipients of a Fulbright Specialist Program grant are not required to adhere to the two-year waiting period before applying for a Fulbright Scholar award. Preference will be given to applicants who have not previously received a Scholar award.
- Department of State employees and their immediate family: Employees and their immediate families (i.e. spouses and dependent children) of the Fulbright Commission in Egypt, the U.S. Department of State, U.S. Agency for International Development, and of public or private organizations under contract to the U.S. Department of State are ineligible to apply for a Fulbright award until one year after termination of such employment.
