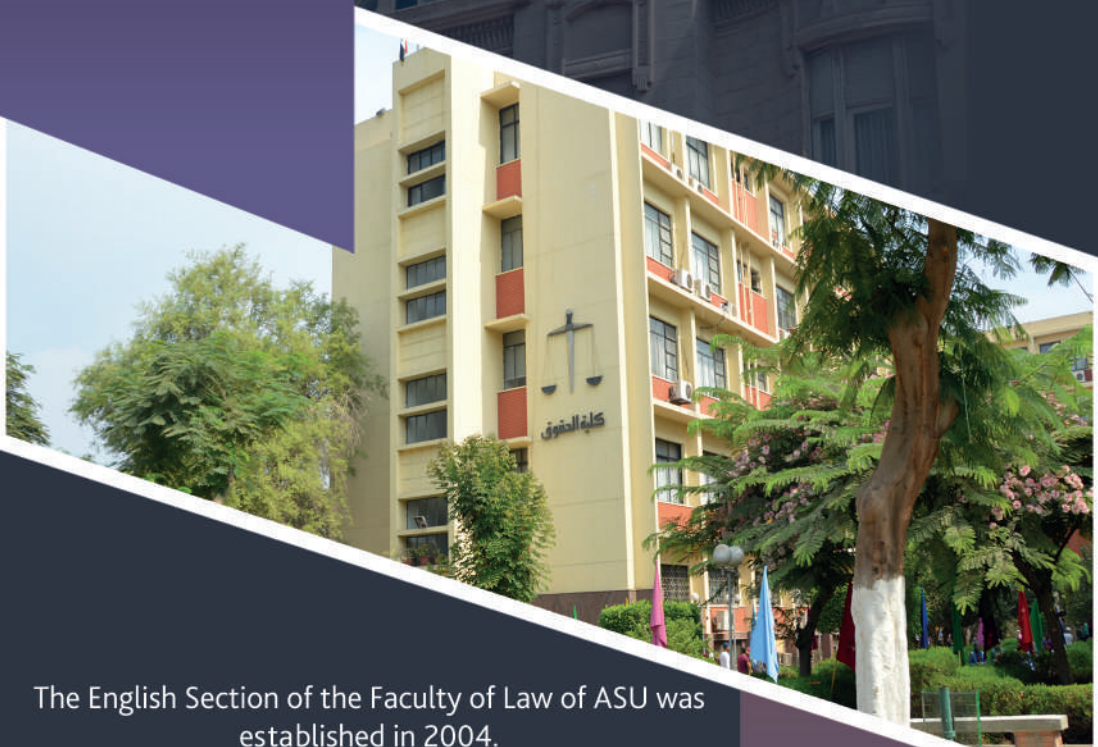




Faculty of **LAW** (English section) Ain Shams University



The English Section of the Faculty of Law of ASU was established in 2004.

It was envisioned that the Section will provide a good legal education in English and Arabic for Egyptians and foreign students who know English and Arabic.

Mission

The envisioned mission of the legal English Section is to provide the national and international legal market with qualified law graduates equipped with a high proficiency of legal English.



Admission requirements for joining the English Program, with credit hours system, at the Faculty of Law:

Requirements:

1 - The student must have a high school diploma from the Arab Republic of Egypt or its equivalent for the academic year 2023/2024 in accordance with the regulations set by the higher Council of the Universities.

2 - He must be among the new students accepted into the general program in the college.

3 - The number to be accepted is within the limits of (500) students.

4 - Students with equivalent foreign certificates and international students will be added to the number scheduled to be accepted into the program, provided that the student is a candidate for admission to the college under the "regularity" system and that his grade in the English language is not less than (C) at a rate of 70%. International students are exempted from the language requirement if the official language of the country of which they hold its citizenship is English.

5 - Without prejudice to what is stated in Clause No. (4), the student's score in the English language subject in the secondary school must not be less than (40) degrees with an average of 80%, and the program's board of directors may amend it according to the high school results.

6 - The priority in joining the program is to the students who obtain a higher grade in high school or its equivalent, and in the event of equality, priority is given to the student who obtains a higher grade in the English language.

7 - Studying in the program is "regular", and cases of affiliation are not accepted at all.

8 - The student's acceptance is not considered final unless the educational service fees are paid in full for the entire semester.

9- Cases of enrollment transfer are accepted according to the conditions stipulated in Article (86) of the executive regulations of Law No. (49) of 1972 regarding the organization of universities and other relevant decisions.

10- It is not permissible to transfer from the English program to other programs in the faculty. However, the faculty Council can review, upon the request of the Program's board of directors, exceptional cases in which the student who requests the transfer is academically struggling.

11- The student must apply to join the program during the announced dates and complete the required documents.

12 - First: It is permissible to accept the transfer of students from corresponding colleges to the English program in accordance with the following rules:-

A - The student must be transferred from a program that applies the credit hours system in the English language.

B - It is permissible to equate the courses that the student has previously passed in the program he is transferring from under the following conditions:

- These courses must be among the requirements for obtaining the degree.

- The student must have passed it with a grade of at least (C) or its equivalent according to the conditions determined by the Faculty Council.

- The weight of the course to be equated in terms of the number of approved hours must not be less than the weight of the course to be equated with.

- The content of the subject studied by the student must be identical by not less than 75% to the subject that corresponds to it in the student's study plan in the program to which he is transferred to.

- If the clearing results in the presence of courses from the program regulation in previous levels at the level to which the student is transferred to and who has not previously studied them, he will be charged for them, and the exam will be placed on the basis of the final grade for the course, unless the Faculty Council decides otherwise, based on the recommendation of the program's board of directors.

- The transferred student must complete at least (70) hours of the hours prescribed by the Faculty in order to be granted a bachelor's degree from the Faculty.

Second: It is not permissible to accept the transfer of students dismissed from the faculty or from any other faculty to study in the program.

Required documents for applying to the English section of the college:

1- A copy of the high school application form.

2- A copy of the nomination card.

3- Two (2) personal photos.

4- A copy of the ID.

5- A copy of the birth certificate.

6 -Fees for opening a file (500) pounds.

TEACHING METHODS

The teaching in the English Section combines classical and modern methods of instruction such as:

- Class lectures
- Applied/comparative teaching: Case law study. This enhances the student's critical and analytical legal skills.
- Supplying students with handouts and supplementary materials using the internet

The English Section graduates are expected to have the ability to:

1. Establish themselves as professionals in the legal practice and judiciary via applying the acquired technical knowledge and intellectual skills.
2. Pursue graduate studies and research in different fields of law in Egyptian and international academic institutions.
